- 4.** The candidates who have appeared for the Main Written Examination and whose register numbers are not found in the above list have not been admitted to Physical Test. Separate communication in this regard will not be sent to those candidates.
- 5.** The admission of the above candidates to the Physical Test is purely provisional subject to the decision of the Commission and subject to the outcome/final orders to be passed to in W.A.(MD) No.181 of 2023 and CMP (MD) No.2247 of 2023 and W.P.No.34604 of 2022, W.P.No.24711 of 2023 and other cases, relating to this recruitment if any, pending on the files of the Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court.
- 6.** Candidates who have been admitted provisionally to the Physical Test are hereby advised to attend the Physical test without fail. Only those who qualify in the Physical Test will be considered for admission to Oral Test.
