



POST OF JUNIOR ANALYST IN THE DRUGS TESTING LABORATORY
INCLUDED IN TAMIL NADU MEDICAL SUBORDINATE SERVICES

The candidates whose register numbers are mentioned below have been provisionally admitted to Physical Certificate Verification for the post of **Junior Analyst** in the Drugs Testing Laboratory included in Tamil Nadu Medical Subordinate Services based on the marks and rank position hosted on the Commission's website on 02.02.2024, for which the written examination was conducted by the Commission on 05.12.2023 FN & AN. The Physical Certificate Verification for the said post will be held on **24.04.2024 F.N.** The Physical Certificate Verification will be held at the Office of the TNPSC, No.3, TNPSC Road, Chennai - 600 003.

Individual intimation regarding the date and time of Physical Certificate Verification will be informed through Commission's website, SMS and e-mail only. Individual intimation will not be sent to the candidates by post.

The candidates with the following Register Numbers have been admitted to Physical Certificate Verification and his/her admission to Certificate Verification and is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Educational Qualification, Experience, etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to further selection process. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.

The candidates who had appeared for written examination on 05.12.2023 FN & AN to the post of Junior Analyst in the Drugs Testing Laboratory included in Tamil Nadu Medical Subordinate Services and whose Register Numbers are not found in the above list have not been admitted to the Physical Certificate Verification for the said post.

6. The provisional admission of the candidates to Physical Certificate Verification does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories and they are not assured of their selection.
7. The admission of above candidates for Physical Certificate Verification is purely provisional subject to the outcome of writ petitions, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.
