2. The candidate whose Register Number is found in the above list has been admitted provisionally to the Oral Test (Phase – III) based on the marks obtained by the candidate in the Written Examination and with reference to the Rule of Reservation of appointments.

The admission of candidate to Oral Test is provisional subject to verification and acceptance of the claim in the online application towards Age, Educational Qualification, Communal Category, PSTM, etc., through original documents. If any of the claims are found to be false or incorrect, the Online Application will be rejected, the provisional admission to Oral Test will be cancelled and the candidate will not be admitted to the next stage of selection.
4. The candidates who have appeared for Written Examination and whose register numbers are not found in the above list have not been admitted to the Oral Test.

The admission of the above candidate to the Oral Test is purely provisional subject to the decision of the Commission and subject to the outcome of final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP No. 29950 of 2019 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.
