 - (c) 'A' in order to defame the reputed person 'B' make ready a wall poster and kept it in his house. The Police Officer seizure the wall poster and arrested 'A'. What officer 'A' has committed?
 - (d) 'A' kept the fire arm person outside the house of 'B' and threatens the 'B' not to come out of his house else he will command the firearm person to shoot at 'B'. Does 'A' has committed any offence?

- (a) 'A' Makes a false entry in the shop book for the purpose of using it as a Corroborative Evidence in the Court of Law. State the Offence 'A' has committed.
- (b) 'A' knowing that 'B' has murdered 'Z', assist 'B' to hide the body with the Intention of Screening 'B' from punishment. Does 'A' has committed any offence?
- (c) 'A' Administer poison to 'B's food with the intention to kill 'B' but 'B' got saved after 20 days of bed ridden from the hospital. What the offence 'A' has committed?
- (d) 'A', 'B', 'C', 'D' planned to murder 'E' who is the Post Master and loot the money in the Post Office. 'A' waited outside the Post office gate to make sure no one goes inside the Post Office 'B', 'C', 'D' went inside and murdered the Post Master and take away the money in the Post Office. Does 'A' Has committed any offence.
- (e) 'A' Instigate 'B' to instigate 'C' to murder 'D'. 'C' murdered 'D'. What the offence 'A' has committed?
- (f) 'A' Cut the tip of the nose of 'B' and thereby caused permanent disfiguration of 'B'. What the offence 'A' has committed.
- (g) 'A' instigate 'B' who is under seven years of age to kill 'C' with knife. 'B' killed 'C'. Does 'A' has committed any offence.
- (h) 'A' is the paramour of Z's wife. She gives the valuable property to 'A' which 'A' knows that it belongs to her husband 'Z', and she has no authority to give the valuable property. What is the offence 'A' has committed?
- (i) 'A' instigate 'B' who is the minor to commit suicide. 'B' commit suicide and died what is the offence 'A' has committed.
