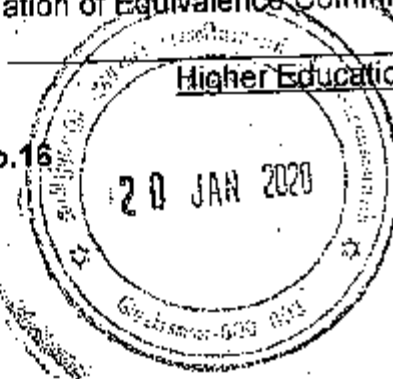

ORDER:-

In the letter second read above, the Chairman, Equivalence Committee / Principal Secretary to Government, Higher Education Department has forwarded the resolutions passed by the 2nd Equivalence Committee held on 06.11.2019 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the equivalence of Degrees offered by various Universities / Educational Institutions to the similar Degrees for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful consideration, approve the following resolution passed in the 2nd Equivalence Committee meeting held on 06.11.2019 under the Chairmanship of the Principal Secretary to Government, Higher Education Department and direct that the following Degree offered by the University be equivalent to the similar degree mentioned therein from the date of issuance of such degree for the purpose of employment in Public Services and also direct that no person shall be eligible for the appointment to any service, class, category or grade or any post borne on the cadre thereof, unless he possesses such special qualifications and has passed such special tests as may be prescribed in that behalf
