ORDER:

In the Government Order first read above orders were issued recognizing the 14 qualifications recommended by the committee of recognition as equivalent to Master of Fisheries Science degree.

2. Representations were received from Fisheries College and Research Institutes and Fisheries students for cancellation of the above order. The Secretary, Tamilnadu Public Service Commission has also stated that the committee recommended to consider and recognise certain qualifications as equivalent to the qualifications prescribed for the post of Assistant Director of Fisheries alone and not to equate those qualifications on par with Master of Fisheries Science. Hence he has requested to issue necessary erratum to the Government Order first read above.

3. After careful examination the Government have decided to recognise the qualifications referred to in the Government Order first read above as equivalent to the qualifications prescribed for the post of Assistant Director of Fisheries, and the following Erratum is issued accordingly.

For the words "M.F.Sc. degree" occurring in Para 4 of the G.O. (D) No.142, Animal Husbandry & Fisheries Department, dated 22.8.2002 the words 'the qualifications' may be substituted.
