2. In the Government Order second read above, orders were issued to the effect that only candidates with B.Com., B.A.,(Eco.) and B.Sc.,(Stat.) Degree qualification obtained in Universities which are recognized by the University Grants Commission be recruited as Assistants in Finance Department. In the Government Order third read above, orders have been issued amending the rules in respect of Assistants in Finance Department incorporating the qualification prescribed in the Government Order second read above.

3) In the Government order fourth read above, orders were issued that the candidates with qualification in Master's Degree in Commerce, Economics or Statistics obtained in Universities which are recognized by the University Grants Commission or a Bachelor's Degree in any one of the above subjects with a pass in the final examination of the ICWA be prescribed for all the candidates including Backward classes, Most backward classes, Denotified Communities, SCs and STs, recruitment as Assistant Section Officers in Finance department.

4) In the reference fifth read above, Tamil Nadu Public Service Commission has stated that the 29<sup>th</sup> Equivalence Committee in its resolution has resolved that M.Sc.,(Statistics and Informatics) awarded by Bharathidasan University as equivalent to M.Sc., (Statistics) for the post of Assistant/Assistant Section Officer in the Finance Department Secretariat.

5) Accordingly the Government after careful consideration direct that the candidates with qualification in M.Sc.,(Statistics and Informatics) obtained in Bharathidasan University are eligible for appointment for the post of Assistant / Assistant Section Officer in the Finance Department in the Tamil Nadu Secretariat Service.

6) Necessary amendment to the Special Rules for the Tamil Nadu Secretariat Service will be issued separately.
