ORDER:

In the Government Order first read above, orders have been issued that the professional degrees such as B.L., B.E., M.B.B.S., B.V.Sc., and B.Sc.(Agri.) are equivalent to any Bachelor's degrees such as B.A., B.Sc., etc., for public employment.

2. In view of the above, Additional Chief Secretary / Commissioner of Revenue Administration in his letter third read above, has recommended to issue necessary amendment to rule 6 in Annexure IX referred to rule 38(b)(ii) of the Special Rules for the Tamil Nadu Ministerial Service.

3. The Government have examined the above proposal in detail and decided to modify the educational qualification prescribed for appointment to the post of Assistant in the Revenue Department by direct recruitment as "a Degree from any University recognized by the University Grants Commission" and to issue the following amendment to the Special Rules for Tamil Nadu Ministerial Service.

4. The following Notification shall be published in the Tamil Nadu Government Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Ministerial Service (Section 22 in Volume III of the Tamil Nadu Services Manual, 2016).

AMENDMENT

In the said Special Rules, in Annexure IX, for rule 6, the following rule shall be substituted, namely:-

"6. No person shall be eligible for appointment as Assistant by direct recruitment unless he possesses a Degree from any University recognized by the University Grants Commission."
